Rights granted by the Artist:

The Artist hereby grants to tank.tv a non-exclusive, irrevocable licence to publish the Artwork in connection with the online exhibition on www.tank.tv (in this agreement referred to as the "show") and associated media relating directly to the show, throughout the World for the life of the copyright in the Artwork and thereafter.

The rights in the Artwork hereby licensed include but are not limited to:

- Use of the Artwork in publicising, promoting and advertising the show and tank.tv, including any tank.tv internet presence;
- Use of the Artwork in screenings related to the publication, promotion of the show (ie. galleries and similar institutions); and
- Use of images/screenshots of the Artwork in any future tank.tv title.

tank.tv maintains the sole discretion to publish images/screenshots of the Artwork in any way, which it may think fit, pursuant to the terms of this licence. *Please note, if otherwise not instructed your work will go into the tank.tv archive once the show is over.*

The work will then only be available for members.

Publication

tank.tv will use its reasonable endeavours to publish the Artwork as set out above, and may also publish images/screenshots of the Artwork in any self promotional material (i.e. media packs) and/or digitally on the tank.tv website (hyperlink www.tank.tv). In any event, any publication of the Artwork shall be subject to tank.tv's sole editorial control and discretion.

tank.tv shall use its reasonable endeavours to ensure that the Artist will receive accreditation for the publication of its work where appropriate.

The Artist warrants to tank.tv as follows:

- It has the right to enter into this Agreement and to grant the rights granted hereunder and that tank.tv's exploitation of the rights granted hereunder do not and will infringe the rights of any third party or require any payment to any third party;
- The Artist is the sole originator and owner of the Artwork and all rights which the artist grants to tank.tv;
- The Artwork is an original work;
- The Artwork does not infringe any third party's statutory copyright or statutory trademark, common law rights, propriety rights or any other rights of any nature; and
- The Artwork and all rights in it are in every respect free and clear of any claim or lien.

The Artist indemnifies tank.tv in respect of any loss, damage or expense that tank.tv may suffer as a result of any claim, which is brought in breach of its warranties and obligations hereunder.

Materials

Original images supplied by the Artist shall only be returned to the Artist, when done with, and an SAE is enclosed with the appropriate postage. tank.tv shall take due care of such material while it is in their possession but shall not be responsible for any loss or damage to any original images while in their possession or in the course of production or in transit or otherwise.

Succession, variation, governing law

This agreement is legally binding upon the Artist and tank.tv and any successor in title of either. The agreement contains all of the terms agreed and no waiver or modification of any term of the agreement will be valid, unless it is in writing and signed by the artist and tank.tv. This Agreement shall be governed and construed in accordance with the laws of England and the English courts shall have exclusive jurisdiction.
